1 NO PURCHASE NECESSARY

No purchase, payment, appointment, or dental service of any kind is necessary to enter or win. A purchase or appointment will not improve your

chance of winning. A free method of entry is available to everyone and carries exactly the same weight as any other entry. See Section 5.

Void where prohibited or restricted by law.

2 SPONSOR

This promotion is sponsored and administered by Prime Dental Tri-Cities LLC (“Prime Dental Tri-Cities,” the “Sponsor”), 4476 W Van Giesen St, West Richland, WA 99353. There is no third-party promoter.

Offices: West Richland, Kennewick, and Pasco, Washington.

3 ELIGIBILITY

Open to legal residents of the State of Washington who are 18 years of age or older as of the date of entry.

The following are **not** eligible: employees, owners, dentists, contractors and vendors of the Sponsor, and any company involved in administering this promotion; and the immediate family members and household members of any of the above. “Immediate family” means spouse, domestic partner, parent, child, or sibling.

You do not need to be a patient of Prime Dental Tri-Cities to enter or to win.

4 PROMOTION PERIOD

The promotion begins September 1, 2026 at 12:00 a.m. Pacific Time and ends September 30, 2026 at 11:59 p.m. Pacific Time (the “Promotion Period”). Entries submitted outside the Promotion Period will not be accepted. Sponsor’s computer and records are the official timekeeper for this promotion.

5 HOW TO ENTER

There are two ways to enter. Both are treated identically in the drawing.

Method A — Appointment entry. Keep a dental appointment at any Prime Dental Tri-Cities office during the Promotion Period. It does not matter when the appointment was booked — an appointment scheduled before September 1 counts the same as one scheduled during September. You will receive one (1) entry for the office where the appointment took place.

Method B — Walk-in entry. No appointment, no purchase, no dental service.

Walk into any Prime Dental Tri-Cities office during regular business hours and ask the front desk for a giveaway entry card. Fill in your name, city and state, date of birth, phone number, email address, and the office you wish to be entered for, and hand it back. That is the whole process. You will receive one (1) entry. You do not need to be a patient, you do not need to book anything, and no one will ask you to.

Walk-in entry cards are available at all three offices — West Richland, Kennewick, and Pasco — during regular business hours throughout the Promotion Period, and must be submitted by 11:59 p.m. PT on September 30, 2026.

One additional entry. You may earn one (1) additional entry, by either method:

- One (1) additional entry if a person you bring with you also keeps an appointment during the Promotion Period; or, by Method B, one (1) additional entry for a second walk-in card submitted on a different day.

Entry limit: two (2) entries per person in total, across all methods and all offices, for the entire Promotion Period. Entries beyond this limit will be void. Automated, mechanically reproduced, photocopied, or bulk entries are void.

6 PRIZES AND VERIFIABLE RETAIL VALUE

Three (3) prizes will be awarded — one (1) to an entrant associated with each office.

Each prize consists of twelve (12) gift cards to local Tri-Cities restaurants, each with a face value of one hundred twenty-five dollars (\$125.00), for a total verifiable retail value of one thousand five hundred dollars (\$1,500.00) per prize.

7 ODDS OF WINNING

Odds of winning depend on the total number of eligible entries received for each office. Three (3) prizes will be awarded in total. Expressed as a ratio, each entrant's chance of winning is 1 in the total number of eligible entries received for that entrant's office.

Actual odds will be posted on this page following the drawing.

8 DRAWING AND NOTIFICATION

Winners will be selected in a random drawing from among all eligible entries on October 2, 2026, conducted by the Sponsor, whose decisions are final and binding on all matters relating to this promotion.

Each potential winner will be notified by phone and email using the contact information provided with their entry. A potential winner must respond and claim the prize within seven (7) days of first notification.
